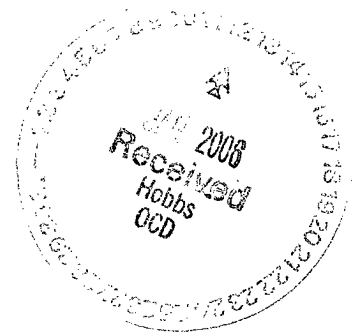
**Spot 35 sx from 11,300' - 11,200'

Cut 5-1/2" csg off @ 7500'.

**Spot 50 sx from 7,550' - 7,400'
Spot 50 sx from 4,250' - 4,100' - Tag
Spot 35 sx from 525' - 425' - Tag
Spot 20 sx from 60' - 0'**

Cut well head off & install dry hole marker on well.
