The subject well is not economic to produce. The well has 8-5/8" casing @ 1165' and 5-1/2" casing @ 4280'. TD is 4300'. Sahara Operating Company proposes to Plug and Abandon this well as follows:

1. NU BOP. RIH w/workstring tbg.
2. RIH w/tbg to TD 4300', circ hole w/mud and spot 40 sx class C cement.
3. Find free point on casing, cut and pull casing.
4. Spot 40 sx Class C cement @ 1200'
5. Spot 30 sx Class C cement @ 300'
6. Spot 10 sx 30' to surface. min 50 ft.

We will restore the location to BLM requirements after plugging.
