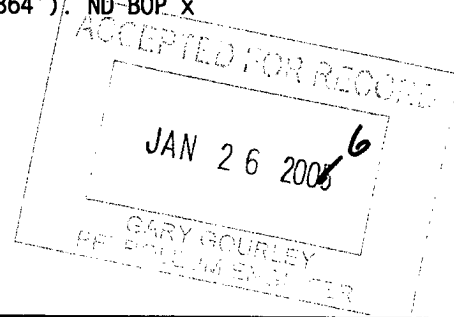

RIH with Reda ESP equipment on 118 jts. 2-7/8" tubing with drain valve (intake set at 3864'). ND-BOP x NU QCI wellhead connection. RD x MO x clean location.

NOTE: Well had been temporarily abandoned since April, 2000.
