If zone is productive, set RBP. Perforate Upper Penn 10202-10210' (16), 10270-10281' (22) and 10308-10316' (16) and stimulate. If production is not adequate, set CIBP @ 10190' and dump 35' cement on plug. Perforate Wolfcamp 9840-9854' (28) and stimulate.
