3. Native soils, stored on site, were used for backfill of the area.
4. NMOCD Pit and Below-Grade Tank Guidelines, dated 11-01-2004, were used for pit closure compliance.
5. Start date on drill cutting removal 07/25/2005.
6. Work was completed by the end of August 2005.

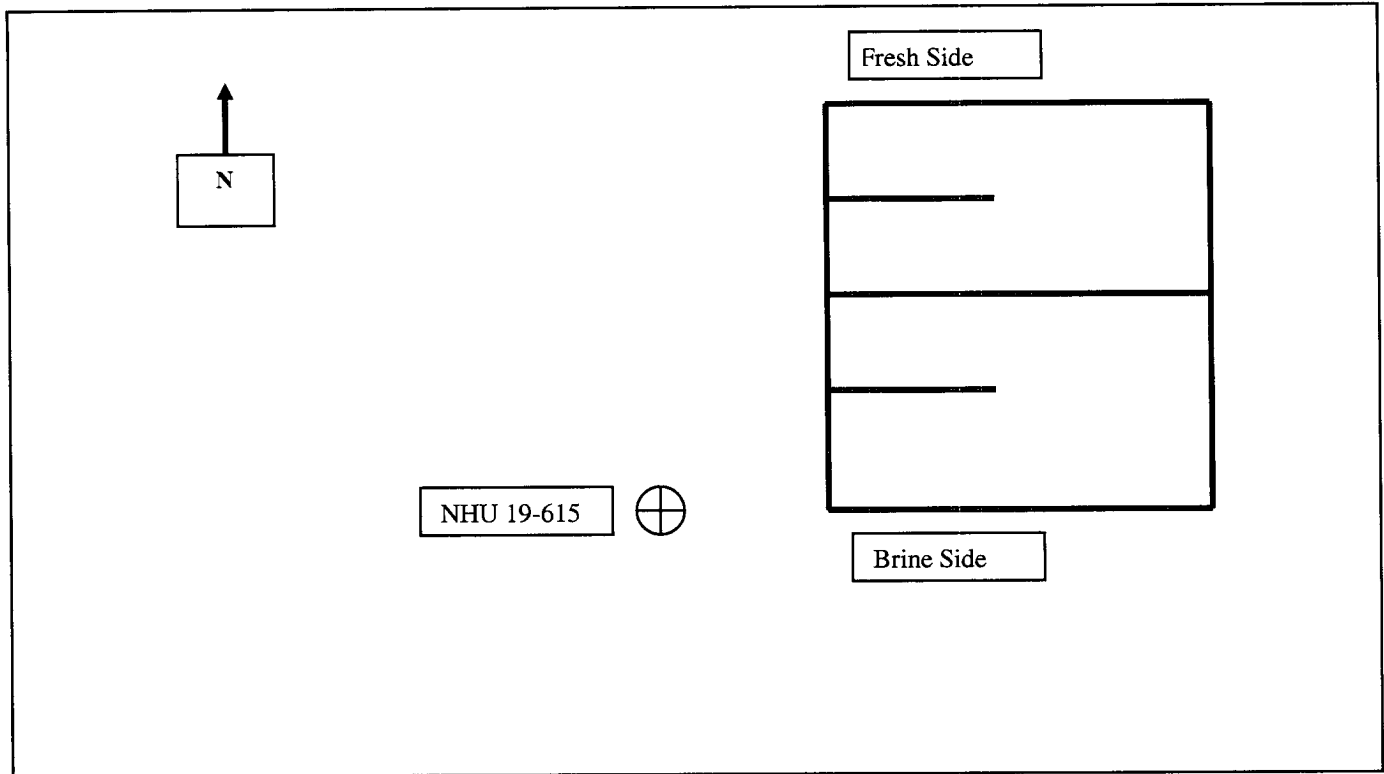
