- 1) Set 5-1/2" CIBP @ 9751' and dump 35' cement on plug.
- 2) RIH w/tubing, circulate plugging mud and spot 100' plug (25 sx) in casing 7781-7681'.
- 3) RIH w/wireline and shoot squeeze holes @ 5648'.
- 4) RIH w/tubing and packer and spot 100' plug (30 sx) in and out of casing 5648-5548'.
- 5) RIH w/wireline and shoot squeeze holes @ 4235'.
- 6) RIH w/tubing and packer and set 100' plug (40 sx) in and out of casing 4235-4135'. Tag plug.
- 7) RIH w/wireline and shoot squeeze holes @ 2716'.
- 8) RIH w/tubing and packer and set 100' plug (30 sx) in and out of casing 2716-2616'.
- 9) RIH w/wireline and shoot squeeze holes @ 1721'.
- 10) RIH w/tubing and packer and set 100' plug (30 sx) in and out of casing 1721-1621'.
- 11) RIH w/wireline and shoot squeeze holes @ 520'.
- 12) RIH w/tubing and packer and set 100' plug (30 sx) in and out of casing 520-420'. Tag plug.
- 13) RIH w/wireline and shoot squeeze holes @ 60'.
- 14) Circulate 15 sx cement in and out of casing from surface to 60'.
- 15) Cut off wellhead. Install marker. Clean location.

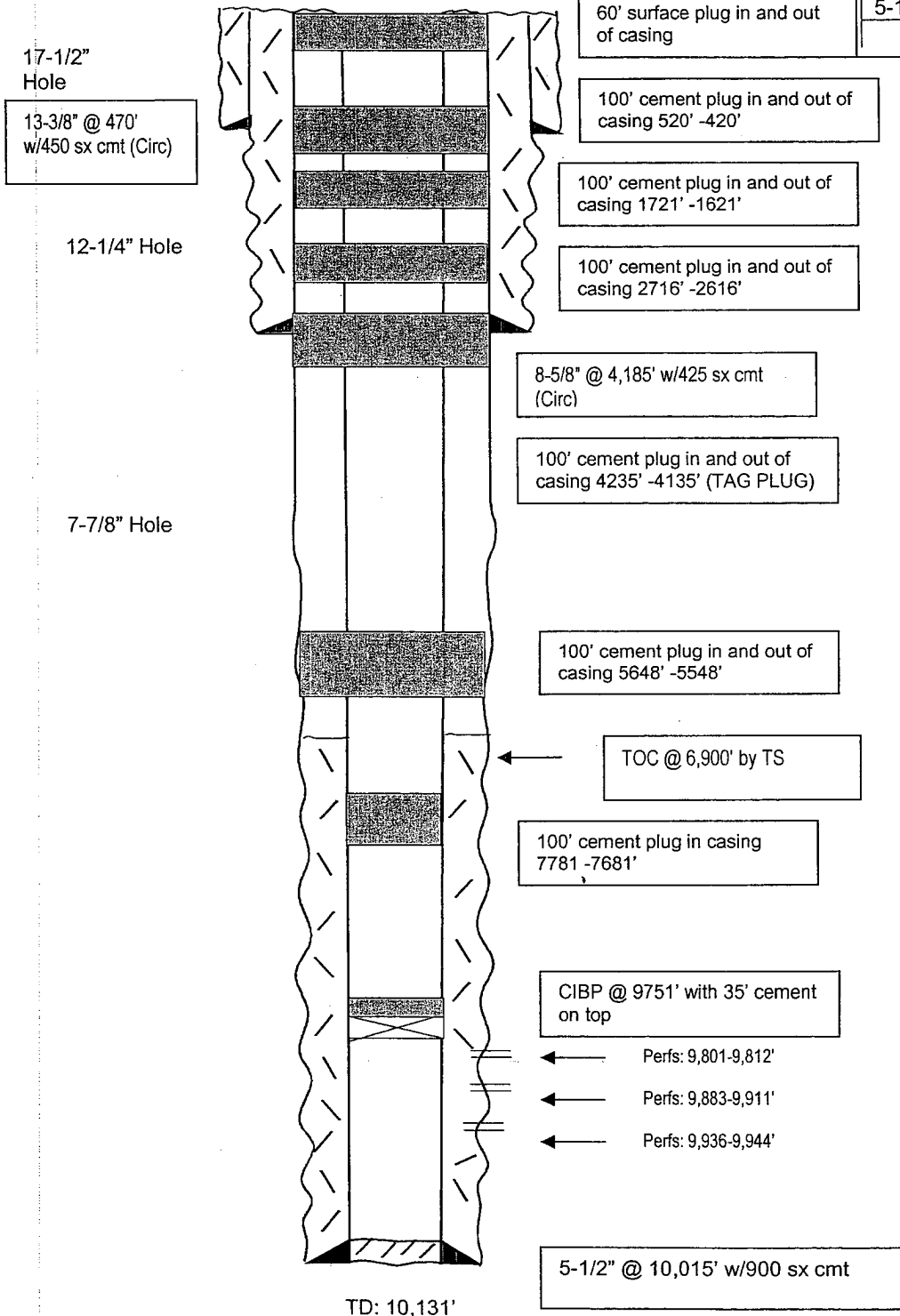
