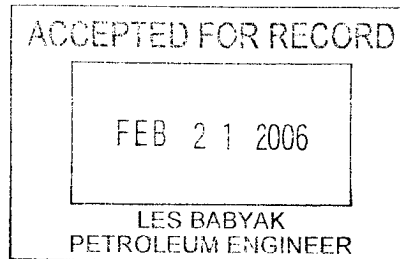

Convert well from an observation well to a producer as follows:

- 1) MI x RU. RIH and pull packer x tubing.
- 2) Drill out CIBP at 4170'.
- 3) Squeeze and reperf the Upper San Andres at 4071' - 82', 4091' - 4117', and 4129' - 46'.
- 4) Acidize perfs and open hole (4201' - 4275') with 2500 gal. 15% acid.
- 5) Run production equipment and RD x MO.
