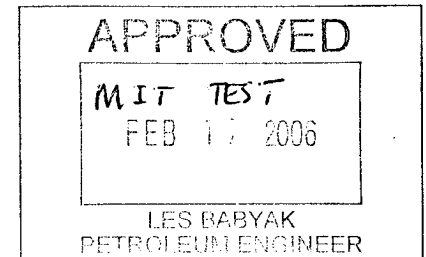

Procedures include:

Removal of downhole equipment  
Removal of the RBP from the Tubb Formation  
Tag for Fill  
Test casing to 500 PSI  
Run injectivity test  
Set RBP 50' (5884') or less above top of Blinbry perfs (5934') Fill well bore with packer fluid and biocide.
