12-21-05 Ran 24 jts 8-5/8" 24# J-55 ST&C casing to 1051'. Cemented lead with 255 sx Lite + 1/4# Flocele (wt 12.5, yld 1.95). Cemented tail with 250 sx C + 2% CaCl (wt 14.8, yld 1.37). Circulated 120 sx to pits. WOC 22 hours. Tested casing to 1000psi for 30 minutes.

12-28-05 Ran 73 jts 5-1/2" 15.5# J-55 LT&C casing in 7-7/8" hole to 3600'.

12-29-05 Cemented lead with 580 sx C + 2% Econ + 3# Salt (wt 12.4, yld 2.21) and tail with 280 sx H (wt 13.2, yld 1.63). Circulated 75 sx to pits. Released rig.

01-04-06 Pressure tested casing to 2000 psi for 30 minutes. Ran CBL and TOC was surface, cement stopped being solid at 2100'.
