11-22-05 Ran 24 jts 8-5/8" 24# J-55 STC casing to 1030'. Cemented with lead of 255 sx Lite + 0.25#/sx Flocele (wt 12.5, yld 1.95) and tail of 250 sx C + 2% CaCl (wt 14.8, yld 1.35). Circulated 90 sx to reserve pit. Pressure tested casing to 1000# for 30 minutes. WOC 33 hrs.

11-27-05 Reached TD of 7-7/8" hole (3377'). Ran 76 jts 5-1/2" 15.5# J-55 STC casing to 3376'.

11-28-05 Cemented with lead of 12 bbl SuperFlush + 575 sx Lite (wt 12.4, yld 2.06) and tail of 360 sx 50/50 POZ + 0.3% R-322 (wt 14.2, yld 1.27). Released rig @ 20:00 hrs.

12-22-05 Pressure tested casing to 1000# for 2 hours.
