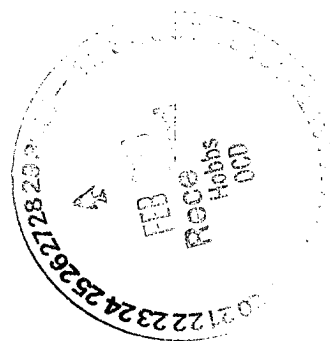
This letter is being sent as a notification of pit closure for the drilling pit at the above mentioned location. This pit will be closed as follows:

1. All drill cuttings and liner will be removed from pit area.
2. All cuttings will be disposed of at Sundance Services, Parabo Facility near Eunice, New Mexico.
3. Native soils, stored on site, will be used for backfill of the area.
4. NMOCD Pit and Below-Grade Tank Guidelines, dated 11-01-2004, will be used for pit closure compliance.
5. Start date on drill cutting removal 03/15/2006.
6. Work is planned to be completed by 04/15/2006.

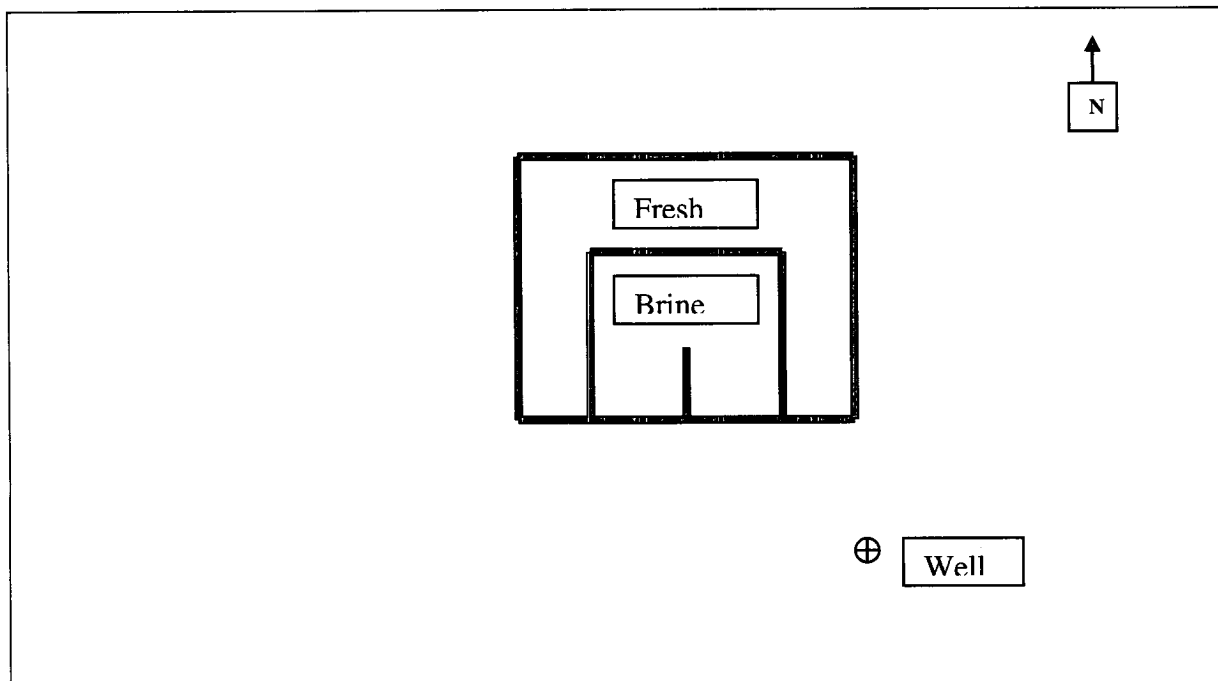
