This letter is being sent as final pit closure for the drilling pit at the above mentioned location. This pit will be closed as follows:

- 1. Drill cuttings and liner were removed from brine side of pit area.
- 2. Drill cuttings from the brine side of the pit were disposed of at Sundance Services, Parabo Facility near Eunice, New Mexico.
- 3. Drill cuttings from the fresh water side of the pit area were mixed with soil and deep buried on site.
- 4. All cuttings from fresh water pit area were encapsulated in a lined area.
- 5. Native soils, stored on site, were used for backfill of the area.
- 6. NMOCD Pit and Below-Grade Tank Guidelines, dated 11-01-2004, were used for pit closure compliance.
- 7. Start date on drill cutting removal was 12/15/2005.
- 8. Work was completed on 01/28/2006.


