Due to this well being in the Lesser Prairie Chicken Habitat and Yates not being able to obtain wavier of the Prairie Chicken Stipulation, Yates Petroleum Corporation is requesting that after the end of the time period for the Prairie Chicken Stipulations on June 15th, Yates be given an additional 30 days to move in a drilling rig and begin drilling operations.
