COG Operating proposes to recomplete from Red Tank; Bone Spring to Bootleg Ridge; Delaware, NW (6925).
COG will test Delaware perms & possibly DHC Bone Spring & Delaware perms.

Recompletion is proposed as follows:

- 1) TIH & set bridge plug @ approximately 8700' to plug off Bone Spring perms.
- 2) Perf Delaware w/ 2 SPF from 8454' - 8458' (4') 9 total holes, 8466' - 7492' (6') 13 total holes, and 8516' - 8522' (6') 13 total holes.
- 3) Acidize Delaware perms (8454' - 8522') w/ 1200 gallons 7-1/2% acid & 50 ball sealers.
- 4) Frac down tbg.
- 5) Production test Delaware. Possibly drill out BP & commingle zones.
