5. Perforate casing at 1,300'.
6. Sqz perforation w/45 sx cement.
7. Tag top of Plug @ 1,050' - 50' above top of Salt.
8. Perforate casing @ 400'.
9. Sqz perfo. w/ 150 sx cement, circulate cement to surface.
10. Cut off Head & Install Dry Hole Marker.

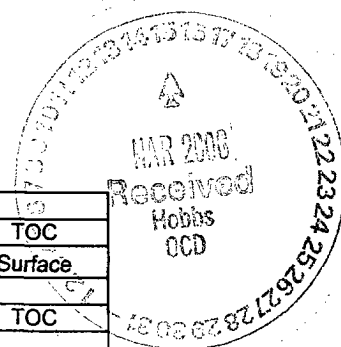

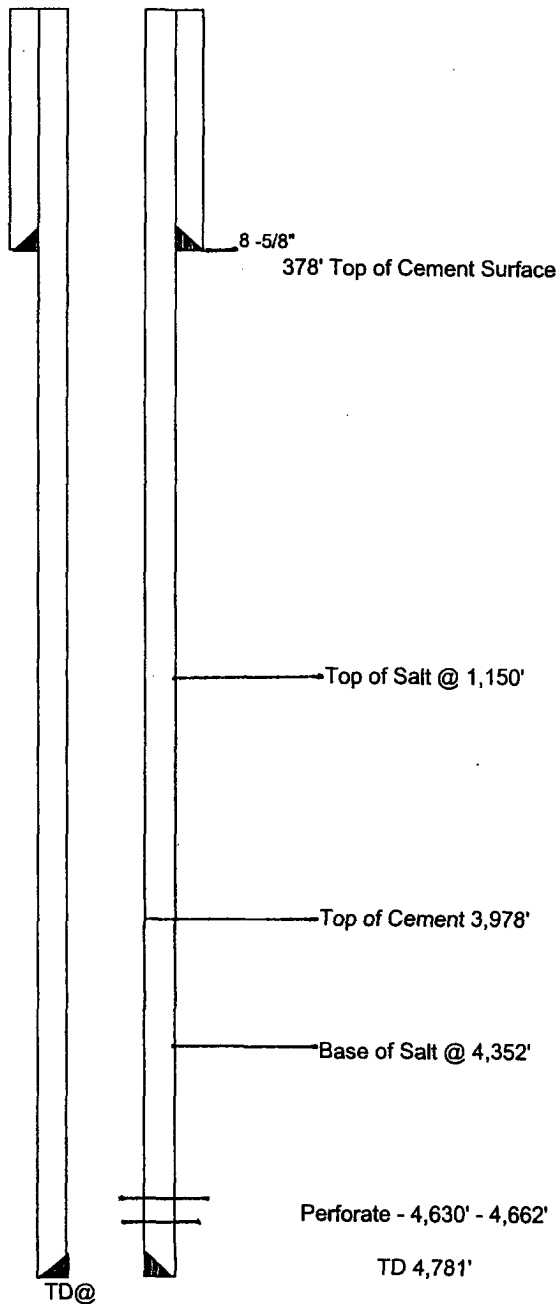
