Yates Petroleum Corporation respectfully requests permission to install a flow nipple and rotating head on the 13 3/8" casing rather than a BOP while drilling the intermediate hole section. 9 5/8" casing will then be set at approximately 4250'. A 5000psi BOP will then be nipples up and tested before drilling below the 9 5/8" casing.
