Mewbourne Oil Company has an approved APD for the above well. MOC would like to change the 5 1/2" production casing string to a 7" production casing & 4 1/2" cemented liner.

Production casing would be 7" 26# P-110 LT&C & BT&C from 0' to 11705' (end of curve).

Cement with 390 sks Class C (60:40:0) w/ yield 2.12 cuft/sk @ 12.5 lb/gal & tail with 400 sks Class H w/ yield 1.18 cuft/sk @ 15.6 lb/gal. Volume calculated with 25% excess. TOC @ 4850'.

Liner would be 4 1/2" 13.5# P-110 LT&C from 10949' (KOP) to 16000' (TD).

Cement with 205 sks Class C (60:40:0) w/ yield 2.97 cuft/sk @ 11.2 lb/gal. Volume calculated with 25% excess. TOC @ 10949'.

All other casing strings remain the same.
