
1. MIRU plugging equipment. POOH w/ production equipment.
2. Run gauge ring. Set CIBP at 2500'. Circulate hole w/ mud laden fluid and pressure test casing to 500 psi.
3. Spot 40 sx cement on CIBP.
4. Perforate at 1000'. Squeeze w/35 sx. WOC & tag.
5. Spot 25 sx cmt at 500'. WOC and tag.
6. Perforate at 100'. Pump sufficient cement to circulate to surface inside/outside 4 1/2" casing.
7. Cut off wellhead 4 feet below ground level.
8. Verify cement to surface on all strings.
9. Install upright P&A marker and cut off anchors.

NOTES: Mud laden fluid consists of 9.5 ppg with 25 sx salt gel per 100 bbls of fluid. If casing will not hold pressure, contact the OCD for instructions prior to preceding with P&A.

Concho reported setting CIBP in 2001 and testing to TA status. No record of where CIBP was set. Operator sqz'd holes from 481'-513' w/ 245 sx. Drilled cmt out from 15' to 500'.
