RIH with packer to test existing squeezed perforations @ 8,896' and 9,896'. Tested good to 2000 psi each. RIH to set CIBP @ 11,600'. RIH with work string. Tag CIBP @ 11,599'. Circulate hole with 900 bbls. 2% KCl to condition hole. Preparing to move in drilling rig to set whipstock, cut window and drill horizontal lateral in the Third Bone Spring.
