I HAVE SPENT \$40,000 + CLEANING THIS FORMATION UP. I STILL HOPE IF I CAN FIND A WELL TO DISPOSE IN, IT WILL START PRODUCING OIL ONCE I GET THE WATER PUMPED OFF.
