

General sealing of valves sales by truck L.A.C.T.

Production Phase

Valves C1 and C2, F1 and F2 sealed (open) while producing into oil tanks. Note: E1, E2, E3 and E4 always remains open.

Sales Phase

S1 and S2 are sealed (open) for sales to the L.A.C.T. The Proving P1 and P2 valves are sealed (closed) in normal operations and opened only when proving. L1 will be sealed (closed) and used only for loading trucks through the L.A.C.T. L2 will be used only when the L.A.C.T. unit is not operational.

Drain Phase

All drain ports are blinded or used only for transmitters to view tank levels. L3 will be sealed (closed) and used only for pulling tank bottoms and cleaning purpose.

On Going Activity

The C1 and C2 valves are sealed (open) continuous for circulating purpose.
