ConocoPhillips Company respectfully requests ^{to shut in} ~~to suspend~~ all operations on Lease NM130738, Section 33, T26S, R32E due to matters beyond reasonable control of the lessee. The Ramsey Gas Plant, which is owned by Western Gas Partners, LP experienced a Force Majeure event on December 3, 2015 and is currently down. After the plant went down on December 3, 2015, the wells on this lease went offline. These wells are operated with gas lift, and require buyback gas from the Western trunk line to have sufficient gas volumes to bring the wells back online. Given the Ramsey plant is down, buyback gas is not available, preventing operation and production from the lease until further notice. ConocoPhillips has not received any guidance from Western Gas Partners regarding a possible restart date for the Ramsey plant, and is unable to speculate when the plant will be available again. In anticipation of the outage being more than 60 days we are requesting to suspend all operations in order to perpetuate the lease.
