Cemented 9-5/8" casing with 305 sacks mixed at 13.7 ppg (1.69 cuft/sx), MW 8.88 gal/sx) and 155 sacks mixed 14.8 ppg (1.33 cuft/sx, MW 6.34 gal/sx). Circulated 46 sacks cement to surface. Casing design factors are as follows for 9-5/8" string: Collapse=5.62, Burst=10.47, Tension=15.68.
