30' EASEMENT DESCRIPTION:

BEING an easement thirty (30) feet in width lying fifteen (15) feet on the right side and fifteen (15) feet on the left side of the survey centerline described below, being out of the southwest quarter (SW ¼) of Section 13, Township 26 South, Range 34 East, N.M.P.M., Lea County, New Mexico, and being out of a parcel of land owned by the Bureau of Land Management. Said centerline of easement being more particularly described as follows:

Commencing from a 2" iron pipe w/ BC1913 for the southwest corner of Section 13, T26S-R34E, N.M.P.M., Lea County, New Mexico;

Thence N 88°58'32" E a distance of 1186.62' to the **Point of Beginning** of this easement having coordinates of Northing=378071.00, Easting=821772.73 feet and continuing the following course;

Thence N 10°35'07" E a distance of 148.46' to the **Point of Ending** having coordinates of Northing=378216.93, Easting=821800.00 feet in the southwest quarter (SW1/4) of Section 13, T26S-R34E, N.M.P.M., Lea County, New Mexico, from said point a 1" iron pipe w/BC 1913 for the west quarter corner of Section 13, T26S-R34E, bears N 26°36'10" W a distance of 2763.63', covering **148.46' or 9.00 rods** and having an area of **0.102 acres**.




