RIH w/ packer, sqz'd 40 sx class C cmt & displaced to 1790'. WOC. Tagged plug @ 1770'. Perf'd csg @ 900'. RIH w/ packer, re-sqz'd 40 sxs class C cmt & displaced to 800' (notified Bob Hoskinson w/ BLM). WOC. 12/10/15 Tagged plug @ 750'. POH w/ all tbg. Perf'd csg @ 60'. Rigged down wireline & tbg tongs, ND BOP. Sqz'd 25 sxs class C cmt @ 60 to surface. Rigged down and moved off. 12/15/15 Moved in backhoe and welder, dug out cellar, and cut off wellhead.
