Tail with 200 sks Class C w/additives. Mixed @ 14.8 #/g w/ 1.32 yd. Plug down @ 8:30 AM 11/30/15. Did not circ cmt. Slow rate lift pressure @ 500# w/3.5 BPM. Ran temp survey indicating TOC @ 2200'. PU 1" pipe & tag @ 2288'. Ran 1" pipe in 8 stages w/375 sks Class C w/3% CaCl2 & 200 sks Class C 2% CaCl2. Mixed @ 14.8#/g w/1.32 yd. Circ 10 sks of cmt to the cellar.
