7/18/2014 Move in rig up and lay down rods. Install BOP. Worked anchor free and POOH with 2 3/8" Tubing.

7/21/2014 Set CIBP at 4740'. Circulated MLF and spotted 25 sx class C cement at 4740'. POOH and spotted 25 sx class C cement with CaCl at 3177'. WOC and tagged at 2931'. POOH and perforated at 1982'. RIH with packer to squeeze perms. Pressured up on perms. Could not establish injection rate. Will perforate at 1932' in the morning as per BLM.

7/22/2014 Perforated at 1932'. Could not establish rate into perms. POOH with packer and RIH to 2033' and spotted 30 sx class C cement with CaCl. WOC and tagged at 1944'. Tag too low. Spotted 25 sx class C cement at 1944' and SION.

7/23/2014 RIH and tagged cement at 1856'. POOH and perforated 5 1/2" casing at 298'. Established circulation down 5 1/2" casing to perms at 298' and up annulus to surface. Circulated cement to surface with 115 sx class C cement. Cut off wellhead and fill up both string to surface with 10 sx cement. Installed below ground marker and cut off anchors.
