11-13-05 Ran 10 jts 13-3/8" 48# H-40 STC casing to 432'. Cemented with lead of 260 sx Premium Plus + 4% Bentonite + 2% CaCl + 0.25# Flocele (13.7 ppg, 1.68 yld) and tail of 150 sx Premium Plus + 2% CaCl (14.8 ppg, 1.34 yld). Circulated 122 sx to reserve pit. WOC 31 hours.

11-15-05 Tested casing to 1000 psi for 30 minutes.

11-21-05 Reached TD of 12-1/4" hole. Ran 91 jts 9-5/8" 40# K-55 LTC casing to 3518'. Cemented with lead of 1000 sx Interfill C + 0.25# Flocele (11.9 ppg, 2.45 yld) and tail of 200 sx Premium Plus + 1% CaCl<sub>2</sub> (14.5 ppg, 1.33 yld). Circulated 245 sx to surface. WOC 33 hrs.

11-22-05 Tested casing to 1000 psi for 30 minutes.
