The gas purchaser for this well has abandoned a portion of their gathering system, including the current meter run for the POCO LOCO FEDERAL NO. 1. It is the intent of Hunt Cimarron L.P. to lay a new flowline to a new location approximately two (2) miles away to deliver gas to the purchaser's system, however we will be required to acquire a right-of-way on federal property to accomplish this. This will inherently require some time.

Hunt Cimarron L.P. requests a shut-in status for six months to allow for the time to obtain the necessary right-of-way and install the flowline to restore gas deliveries and sales.


