- MIRU PU to re-enter P&A well
- Remove welded cap on well
- Drill out plugs to 1630' (this is 50' below 9-5/8" csg shoe)
- Set CICR @ 1535' and cmnt squeeze.
- If sqz successful, cap CICR w/100' of cmnt and proceed to replace previous two cmnt plugs to surface as before. @1235' + 350' to surf.
- If cannot sqz (goes on vacuum), over displace by 1 bbl, wait on cmnt to cure, and pressure test. Re-squeeze again if not holding pressure. Proceed to replace two previous cmnt plugs to surface as before.
- Install P&A cap.
- RDMO PU

During this procedure we plan to use the closed-loop system with a steel tank and haul contents to the required disposal per ODC Rule 19.15.17
