On July 10, 2009, SESI spoke with Kevin Bussell and Ernie Jaquez representatives of the Bureau of Land Management (BLM) in regards of location area. Mr. Jaquez stated that the area just needs the power poles and debris from location be removed and no excavation taken place. Mr. Jaquez requested that the site not be re-seeded.

On July 28, 2009 Roosevelt County Electric Cooperative removed power lines and power poles going into location. The power boxes, pallets, and flow line have been disposed of at an authorized disposal site.
