On July 8, 2009 SESI was onsite to perform clean up of staining from around dry well marker. The area was excavated to a depth of approximately 2' and 108 yards of contaminated soils were transported to an approved NMOCD disposal facility. The caliche from location pad was transported to a nearby landowner to place in a low area at his windmill. The production equipment and concrete pads were removed and transported to an authorized disposal facility. All abandoned surface and subsurface pipelines and poly lines have been removed. The area was then backfilled with onsite soils from surrounding area and contoured to natural grade. The entire location and access road has been seeded with the prescribed mixture provided by the BLM. The entrance to the access has been protected from vehicular travel by utilizing caliche from lease road as a barrier to prevent entry on the road.

On July 28, 2009 Roosevelt County Electric Cooperative removed power lines and power poles going into location. The power boxes and conduit have been removed from location area.
