- 7/24/2015 TIH tagged plug @9265'. Set 70sx H+2% Cacl-2 @ 9265', WOC 4 hours. Tagged plug @ 8925'. Set 25sx H+2% Cacl-2 @ 7617'.
- 7/27/2015 Started casing test @ 9:04AM tested good to 1500# for 30min. Jim w/BLM approved to proceed to next zone.
