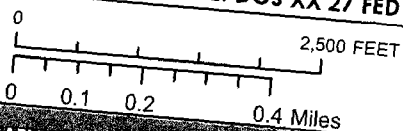

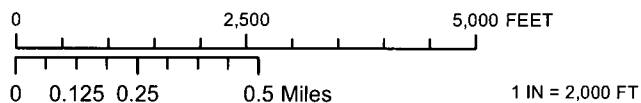

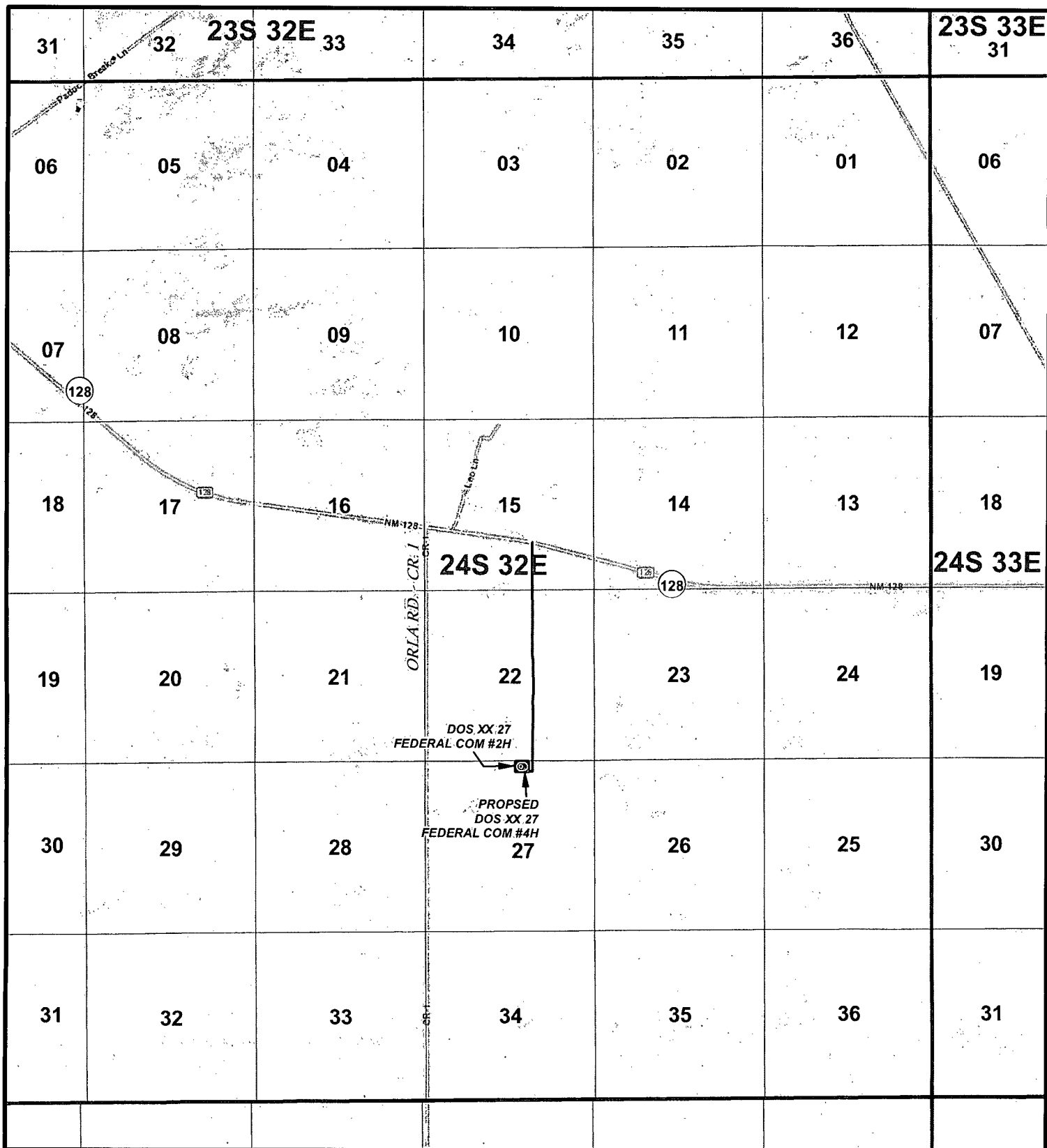
LOCATION MAP TOPO 12/03/2015 A.P.

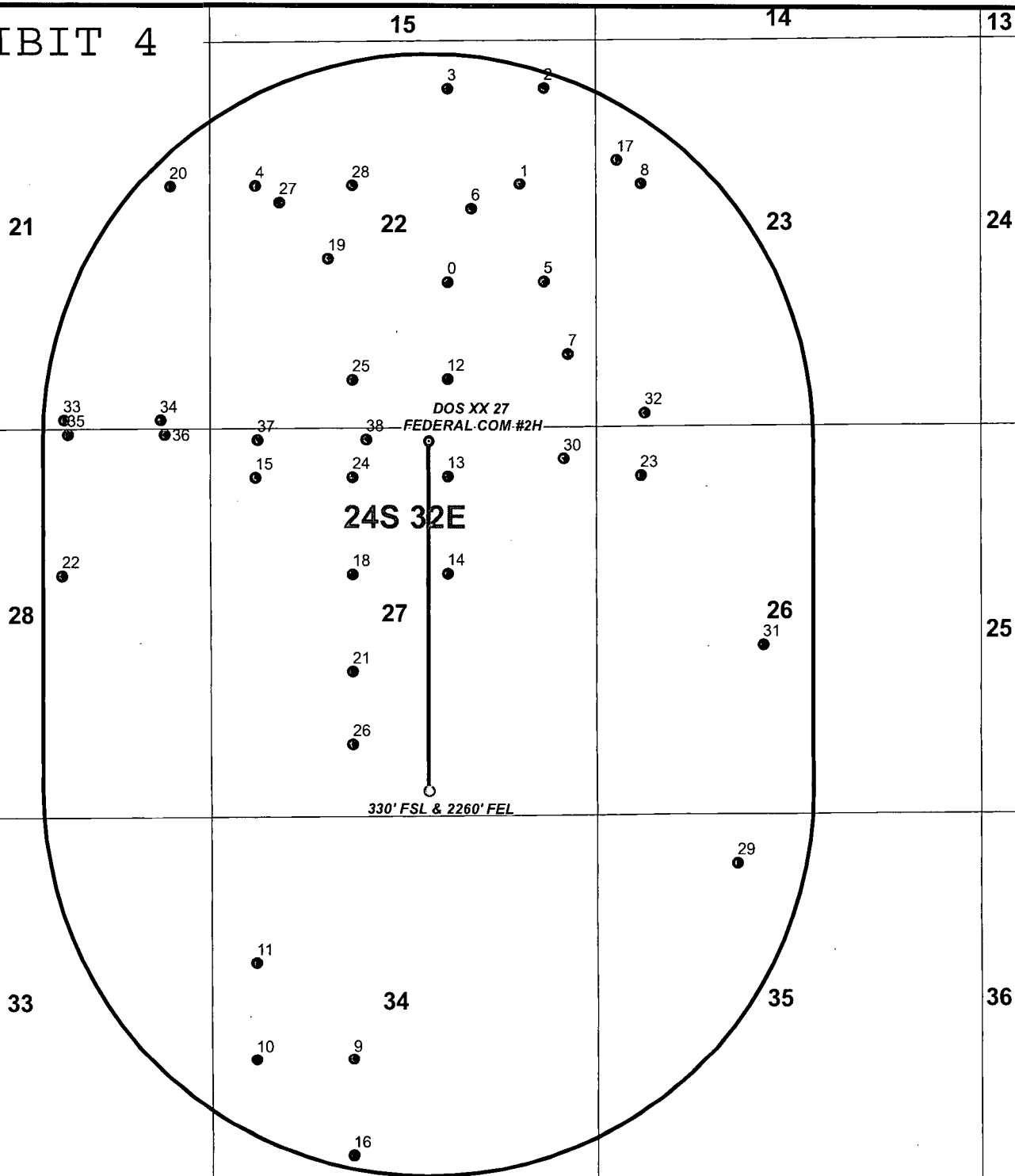
