(3/29/16) MIRU, killed well, ND wellhead, NUBOP, RU workfloor. POOH w/ 126 jts 2 7/8" tbg, ESP, ESP equipment tested negative for NORM. RIH w/ 5 1/2" CIBP, 10 jts 2 7/8" tbg, mixed and dumped 4 sxs cmt on top of CIBP, and cont to RIH w/ 129 jts 2 7/8" tbg. Set CIBP @ 4040', shaken and dumped cmt on top of CIBP, pumped 25 BBLs FW into tbg, and pressure tested csg to 600 psi, which held. Circ well w/ 90 BBLs 10# pkr fluid. RIH w/ 8 jts tbg, tagged TOC @ 3994'. POOH w/ 118 jts tbg, seat nipple, and set tool. RD workfloor, ND BOP, NU cap flange. Ran MIT for NMOC, pressure tested casing to 600 psi for 30 min, which held.
