Injection riser and old well sign by marker. NEED TO CORRECT MARKER, REMOVE ANCHORS, AND REMOVE WELL SIGN. NEED TO REMOVE INJECTON RISER 2 FOOT BELOW GROUND LEVEL AND DISCONNECT INJECTION LINE AT STATION.

Comments on Inspection: DO NOT RELEASE BONDS. 1 steel anchors on west side of location. Bolts protruding out of concrete poured base. Power pole cut off 1 foot above ground level NW of marker. Injection riser next to marker. NEED REMOVE ANCHOR. NEED TO CUT BOLTS OFF FLUSH WITH CONCRETE. NEED TO CUT POWER POLE OFF BELOW GROUND LEVEL. NEED TO REMOVE INJECTON RISER 2 FOOT BELOW GROUND LEVEL AND DISCONNECT INJECTION LINE AT STATION.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Divison Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well.
