Dear Producer:

Pursuant to the terms of your gas purchase contract(s) with Frontier Field Services, LLC ("Frontier"), this letter is to notify you of a Force Majeure event affecting Frontier's Maljamar System ("Maljamar").

Transwestern Pipeline (TWPL) has informed us that they will be replacing a 10" valve on June 15, 2016 that will require an isolation and blowdown of the Maljamar Lateral and complete shut down of the Maljamar Plant. Please take the necessary actions to shut in all of your delivery points no later than 12:00 p.m. MT on Tuesday, June 14, 2016 so we can blow down our facilities and be ready for TWPL to begin their work on the morning of June 15, 2016.

- Shutdown dates: June 14, 15, 16, 2016

Please be sure to physically block in the gas sales line and do not rely only on the pressure relief valve (Klrmay). Feel free to coordinate these efforts with any of the Frontier representatives referenced below. TWPL anticipates having the valve replaced and the lateral purged and packed and back in service on the morning of June 16, 2016.

Frontier representatives will notify producers when we are ready to resume accepting gas from the delivery points. Frontier will also be performing maintenance during this time period and should the repairs and maintenance required take longer than anticipated, you will be notified accordingly.
