Yates Petroleum Corporation plans to plug and abandon this well, present depth is 90'. Shows 10' of water. 30" at 10' = 1.82 yd/3, 20" from 10'-90' (80' total) = 6.5 yd/3. Propose dumping 43 ft/3 of coarse bentonite chips followed by 6.6 yd/3 of ready mix. Allow 20% extra for hole enlargement. After filling well cut off locking device and install ground level dry hole marker. Clean up any disturbed area.
