HYDRO-TESTED IN WITH THE TUBING AND DROPPED JACAM PELLETS (FOR CORROSION AND BACTERIA). RAN THE REPLACEMENT PUMP, FLUSHED THE TUBING WITH SOAPY WATER AND RETURNED THE WELL TO PRODUCTION ON 4/17/16. THE WELL DID NOT STAY PUMPING, RIGGED UP ON 4/18/16 AGAIN, UNSEATED THE PUMP AND FLUSHED THE TUBING WITH PARAFFIN SOLVENT. RETURNED THE WELL TO PRODUCTION AGAIN 4/19/16. THIS WELL WILL BE ON ROTATIONAL PRODUCTION.
