The Prohibition #2 SWD, This spill went off the well pad and onto the pasture. It appears to have fallen inside previously cleared (arch) area. The BLM approves the submitted process.

The Prohibition 12 Federal 7, The area surrounding AH-1, I would like to see the 1900 ppm removed to 1.5-2'. BLM will approve the procedure with this change.

The BC Federal 26, The area surrounding AH-1, I would like to see the 1600 ppm removed to 2-2.5'. BLM will approve the procedure with this change.

Geoffrey,

We have 3 COG pending work plans that have been recently submitted (emailed) for your approval and these sites are listed below. Let me know if I need to meet with you to review the work plans, if this helps the approval process.

COG – Prohibition #2 SWD (emailed 3-28-12)
COG – Prohibition 12 Federal #7 (emailed 3-29-12)
COG – BC Federal #26 (emailed 3-9-12)

On the chloride question, the samples immediately above at 6-7' and 9'-10' and 14'-15' showed declining chloride concentrations of 511 mg/kg, 275 mg/kg and <200 mg/kg, respectively. At 19-20', the concentrations slightly increased with depth to 543 mg/kg and this spike appears to be cross-contaminated from the upper sandy soils at the site.

The chloride concentration at 19' to 20' in BH-2 increases to 543 mg/kg from the < 200 mg/kg concentration observed in the 14'-15' sample. Please clarify. Thank you.
