Lime Rock Resources proposes to drill out CIBP & cement at 8632' and return well to production.

Sheridan Production Company neglected to file a Form C-103 after deepening the well in December 2008. According to the limited information in Sheridan's well files, the above well was deepened to approximately 9059' (PBT 8965'). Perfs were added from 8855'-8915' (70 holes) and 8925'-26' (4 holes).

A Form C-103 was filed by Sheridan Production Company to TA the well on April 13, 2010. It was approved by OCD on April 19, 2010. In May 2010, Sheridan set CIBP at 8677' w/35' cement on top to TA the well.
