"Matador would like to plan on having the option to float our casing to bottom. To do this we would have the lateral section filled with air while running. Matador requests approval to utilize casing flotation tool on production casing while running into hole. Will place tool near base of curve and plan to float ~7000 ft of lateral production casing to TD. Current casing design (5-1/2" 20# P-110) meets minimum required collapse design factor with full internal evacuation and a collapse force equal to 9.00 ppg mud gradient. At TD will rupture flotation tool and circulate out air through surface pressure control equipment prior to start of cementing."
