SOGO III proposes plugging as follows:

- RU pulling unit and BOP and pull and tally tubing. Set CIBP @ 4950' and dump ³⁵ 20' of cement. OR 25sx w/tbg.
- Perforate @ 4772' (base of salt). Squeeze w/ 35 sx. WOC and tag.
- Perforate @ ~~1375~~ (top of salt). Squeeze w/ 35 sx. WOC and tag. PERF @ 1300'
- Perforate @ 471'. Fill hole in and out w/ cement (estimated 40 sx)
- Cut off wellhead and install P&A marker. Clean and level location.


