Average Daily oil = 28 BPD  
Estimated Flare per day = 72 +/- MCF

This circumstantial flare could result longer than 24 hour period and possibly more than the 144 hours cumulative authorized under NTL4A III.A. Flare volumes will be reported on OGOR.
