
COG proposes to make the following changes to the casing and cement program:


Drill a 12-1/4" hole to 2800' w/brine water; run 9-5/8" 40# J-55 LTC and cement to surface.
 Remainder of the well is as permitted.

The reason for these changes is because red reactive shale was encountered in Pan Head Fee #4H and #22H from approximately 2250'-2750' and it would be advantageous to cover that with the 9-5/8".
