Comments on Inspection: DO NOT RELEASE BONDS. Rule 19.15.25.10 (D) requires that restoration of location be completed within 1 year of completion of plugging operations. This well was P&A'd in January of 2015. PA marker was found to be correct. Stub pole and conduit west of marker. 2 power poles and transformers south side of location. NEED TO REMOVE STUB POLE, CONDUIT, POWER POLES AND TRANSFORMERS. IF POWER POLES ARE NOT THE PROPERTY OF OPERATOR, A COPY OF CORRESPONDENCE TO PROVIDER OF POWER STATING THAT WELL HAS BEEN P&A'D AND REQUESTING REMOVAL OF ALL SERVICES SHOULD BE ATTACHED TO THE C103 FOR RELEASE.

In the event that a satisfactory response is not received to this letter of direction by the "Corrective Action Due By:" date shown above, further enforcement will occur. Such enforcement may include this office applying to the Division for an order summoning you to a hearing before a Division Examiner in Santa Fe to show cause why you should not be ordered to permanently plug and abandon this well.
