Legacy Reserves respectfully requests approval of an exception to the reclamation of the existing location pad site of Lea Unit #30H because the entire location site is necessary for sufficient room to place the drilling rig and other associated equipment necessary to safely and efficiently drill and complete another well on that location. Many of the existing locations at Lea Unit are planned to have one or more additional drill wells in the future. As has been requested by the BLM, we will attempt to minimize new surface disturbances and utilize existing location pads whenever possible.
