Chevron actually never made it out of the original well bore that apparently had been washed out by the original acid jobs performed, due to the fact that we continually got a percentage of cement back to surface as part of the cutting analysis done by the Mud loggers, as we drilled a sidetrack. This resulted in us tagging up on the packer that we were trying to sidetrack around. We were in an attempt to perform a second sidetrack immediately above the packer, when the cement set up around the workstring as we were setting the second whipstock. Due to small size of the workstring at that depth (17,193') inside casing. At this point, Chevron has decided to T & A the well to further evaluate our options for future operations and Kenneth Hodges/ Drilling engineer has reached out to Chris Walls/BLM for guidance to ensure we met BLM requirements.
