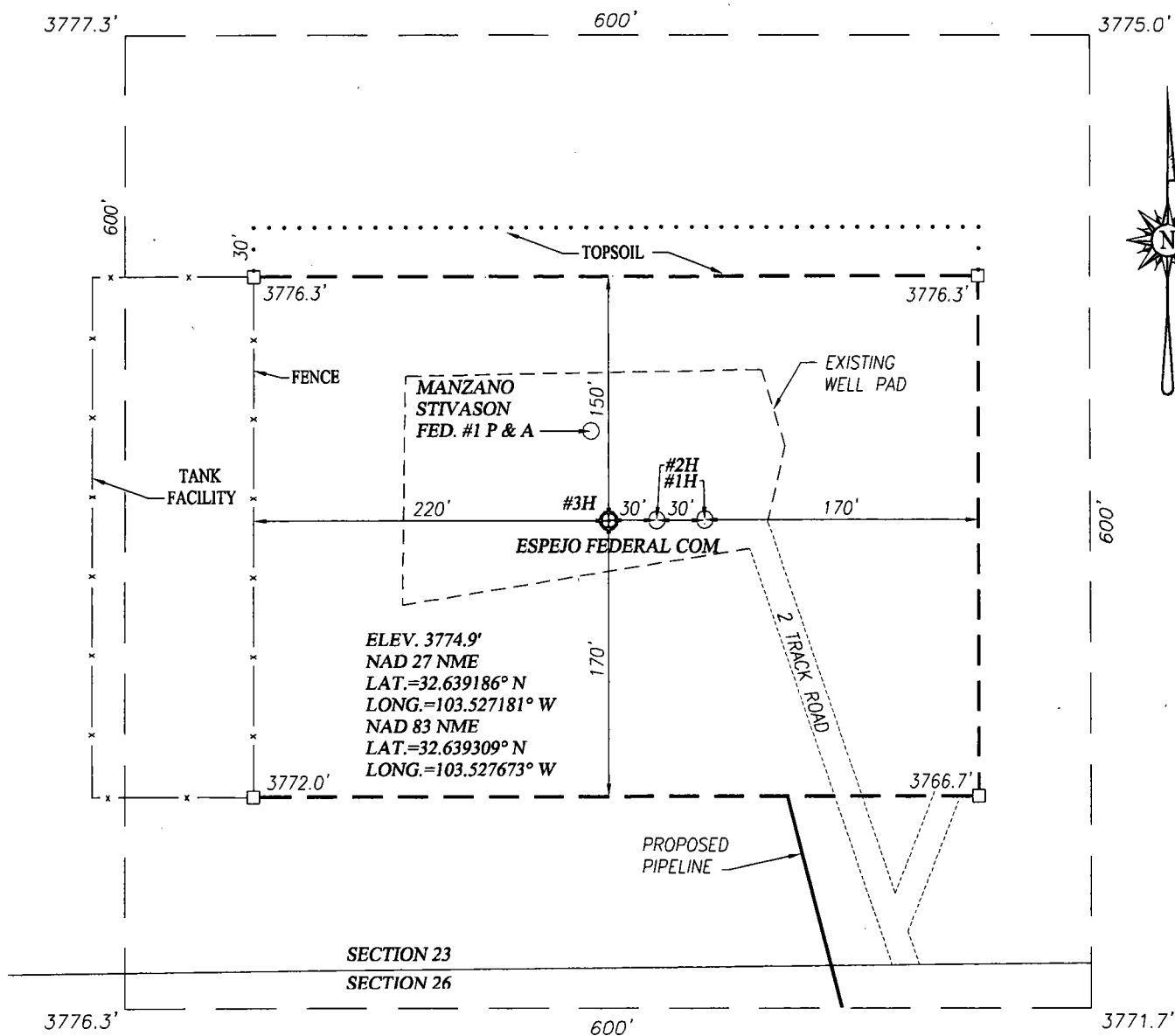


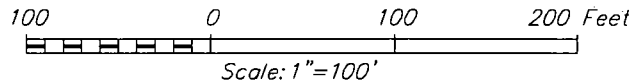
WELL SITE PLAN

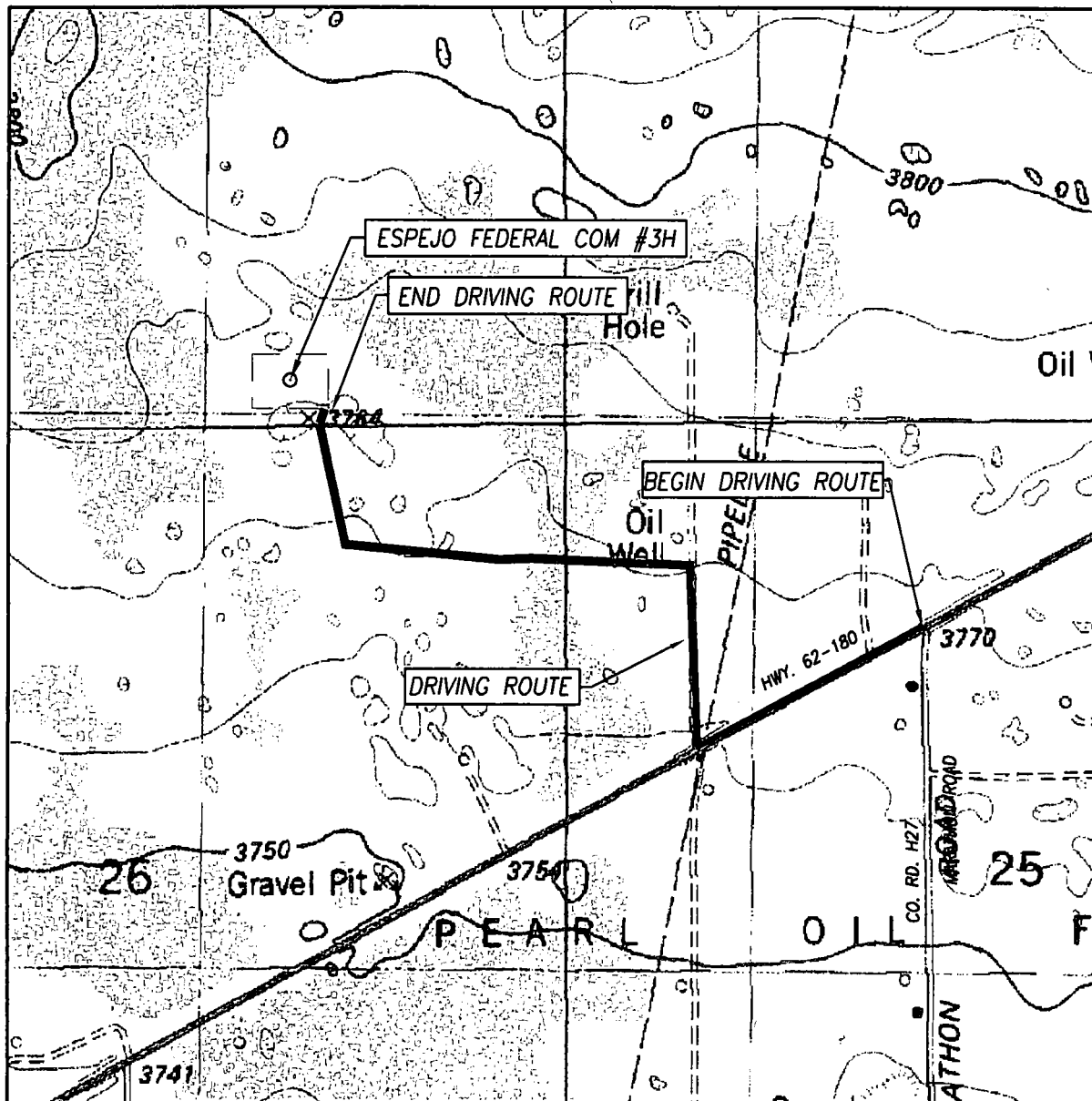

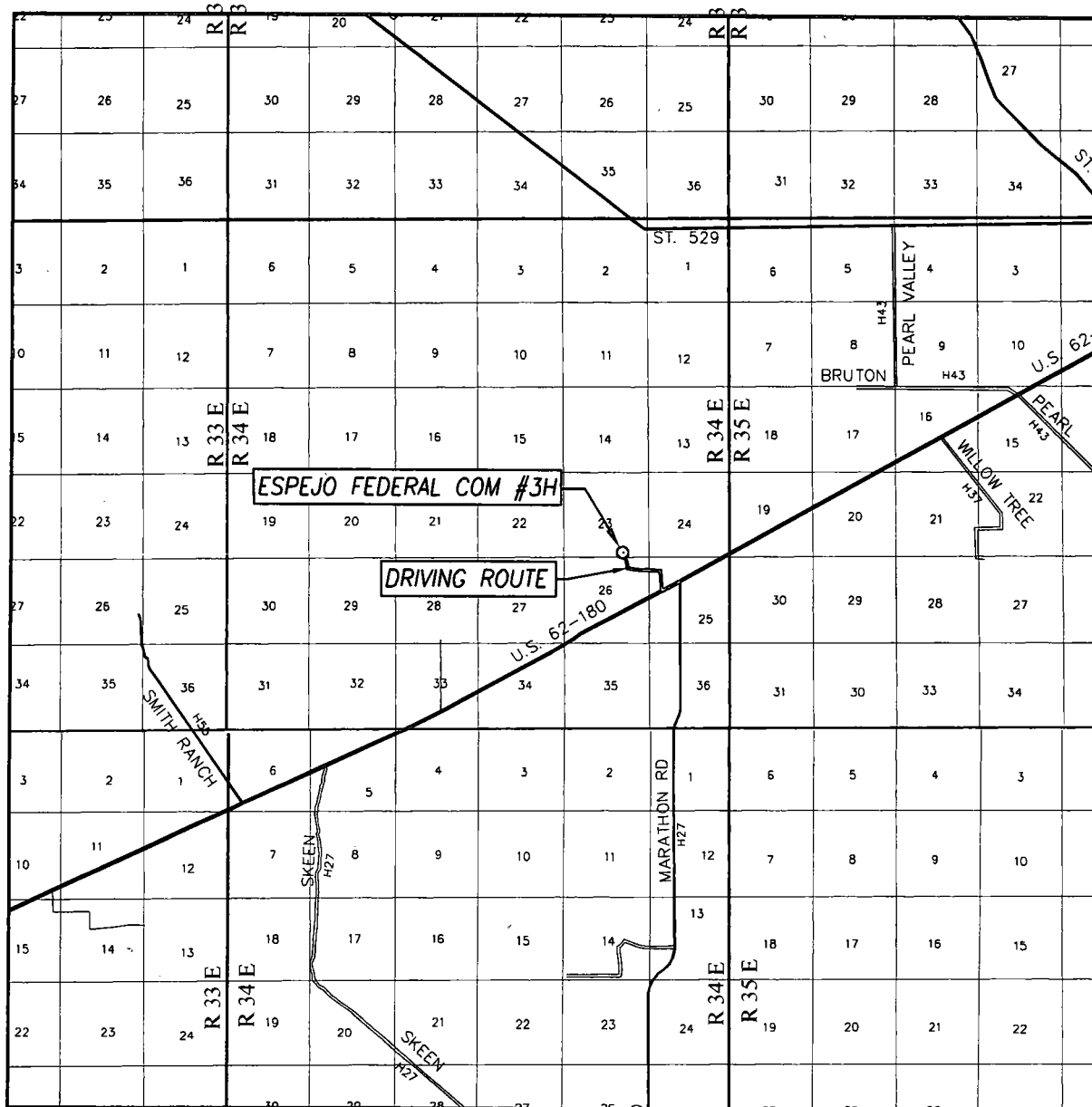

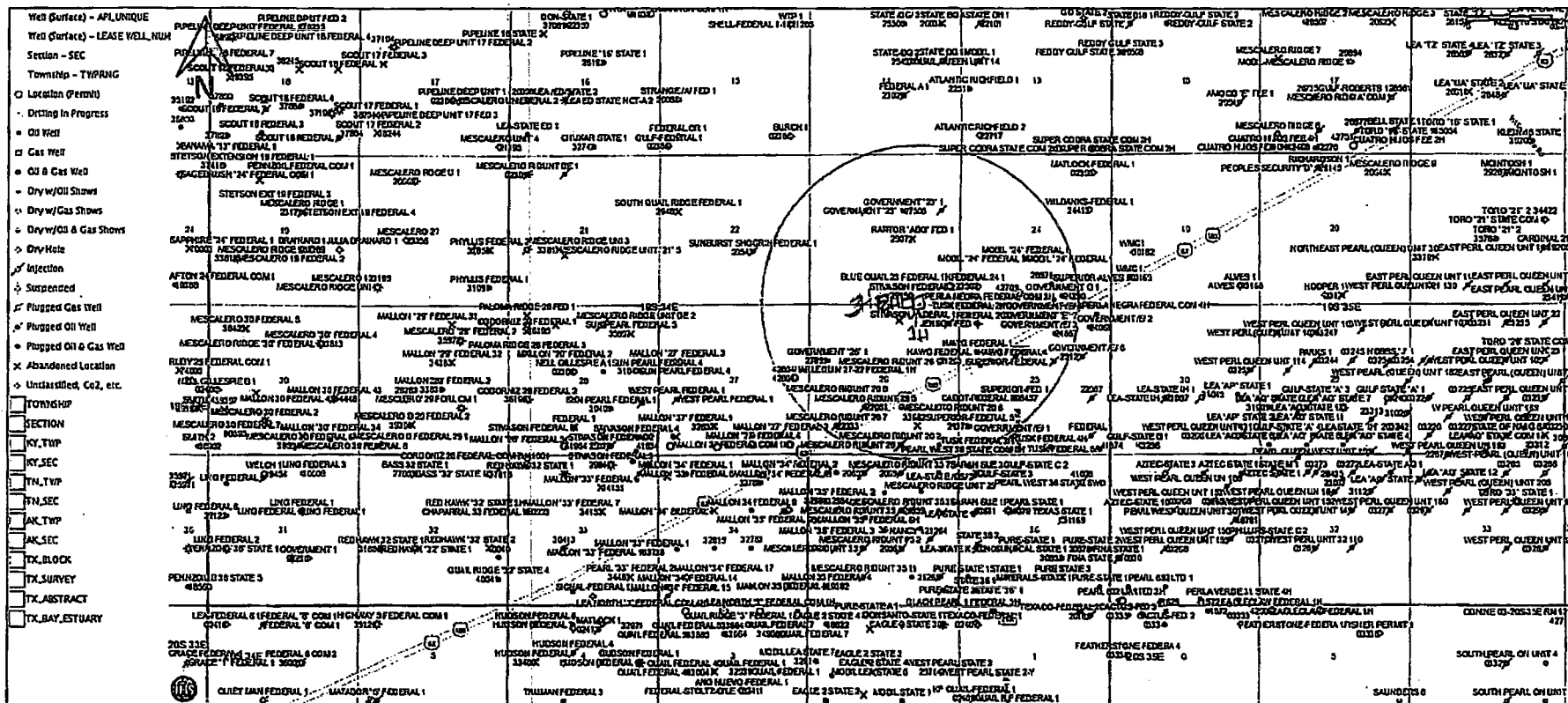
