- Drillout two DV tools @ 3905' and 4770' to PBSD (Float Collar at 5383' MD)
- Losses were encountered while drilling formation.
- Log well for cement integrity and formation characterization.
- Move off well for a few days to evaluate logs.
- Based on log results, ascertain quality of primary cement job on injection string and plan for remediation as necessary.
- Move back on well to complete, including any cement remediation.
- Select perforations from cased hole logs, perforate, and acid treat
- RIH with injection equipment
- Turn well to injection
